



PUBLIC REVIEW AND COMMENT

Los Angeles World Airports (LAWA) has prepared a Draft EIR for the Central Utility Plant Replacement Project (CUP-RP). The CUP-RP would replace the existing CUP and maintenance shop building at the Los Angeles International Airport (LAX), including the boilers and electrical co-generation equipment and the existing cooling tower system; construction of an underground thermal energy storage (TES) tank; electrical upgrades to include a new electrical substation and a retrofit of the existing LADWP substation; installation of a new fire management system and a new fire life safety system; and, replacement of the direct buried chilled water and hot water service lines in the CTA. The project includes the demolition of the existing CUP and associated ancillary facilities. In addition, the project includes the potential installation of a recycled/reclaimed water pipeline and off-site water treatment system and the possible use of biogas from digesters at the Hyperion Treatment Plant (HTP). The Draft EIR will be available for public review on July 30, 2009 at the locations listed below.

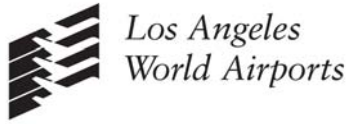
